### Call To Order -6:02 pm

- Absent: none. Quorum present.

## **Landscaping Conversation with Tom Cain**

- Question of landscaping arose and potential need for LHD guidance. Tom had put together a history of landscaping and possible guidelines.
- Concern from some board members was presented about promoting grass lawns
- Tom's input:
  - There is lots of evidence of what kinds of landscapes were present in Fort Wayne historically
  - Discussed history of attitudes toward lawns and the impact of the environmental movement of the 1960s
- We will put something on the website regarding resources and history of landscapes in the area.
- We will remind neighbors to get HPC approval for major landscape changes

### **Financial Update**

- Income: \$236.79 from memberships and interest
- Expenses: \$16,559.33
  - Storage unit monthly fee is increasing by ~\$60/month
  - Beautification grants, Constant Contact subscription
  - \$15,000 contribution to Hemphill-Smith Foundation
- Total Assets: \$241,016.19
- Unrestricted assets: \$176,370.62

#### **Finalize WCNA Spending Plan**

- Joel provided the draft of the spending policy to present to the membership meeting next week.
- Change: "profits" will be "excess revenue above expenses"
- Change: instead of "all expenditures will be shared with the membership at its monthly meetings" it will be quarterly statements
- Change: \$250 donation must not benefit a for-profit organization, political entity, or house of worship
- Joel will make final changes and send out.

- Kelly: update on new signs for neighborhood. Kelly talked to the city employee heading the grant program.
  - We would add to existing signs rather than replace
  - O Dimensions: 16x16" round cut
  - Reached out to Graphics Direct (used them with the home tour)
  - Quote: total per sign before installation: \$240.00
  - \$354 plus tax with installation
  - Would need to submit light pole numbers to the city
- Joel will put together a draft survey to solicit feedback from the neighborhood for "transformative neighborhood projects"
  - Idea to send out postcards with QR code for survey and other important info
  - Once a year expense at the beginning of the year to boost membership and attendance?

# **Allen County Planning Zoning Changes**

- Accessory Dwellings- goal is to help with housing shortage
  - Eliminate public comment, make it a staff approval process
  - Limited to one per property
  - Would eliminate setback requirements
- We don't have much input. Joel sent a letter asking for LHDs to be an exception. The final vote does not have final comment.
