New Business: (George)

Paw Sensitive Poop Removal reached out to us. They install and service waste receptacles. We could consider having receptacles on the corners. They do this for the pufferbelly trail. No info on cost yet. George will follow up and get more info.

2025 Spending Priorities

- Could we also cost share lead service line replacement? There is an income-based program.

- \$2600 for City Utilities Project Area. Free for households less than \$45K, 65% reduced if you earn under \$60,000, 30% reduced for under 75K. Financing optional–The cost is put directly on the water bill. We could start by putting out the information about this program. Agreed to do this for a year.
- Painting the jersey barriers was suggested. We would need approval from dept of transportation. This would be Public Art. As a courtesy, we should get approval from homeowners.

2025 Budget

- Downgraded budgeted H&G revenue on budget by \$10,000 (to reflect likely decrease in 2025 due to weather). \$59,700 totally budgeted
 - \$25k to \$26K on budgeted expenses
 - o For a net of \$33K
 - o budgeted combined net \$36K for H&G Tour and ArtsFest
 - Suggestions: add budget line for trash cans for each house (\$250)
 - Need new Square readers x5 (\$250)
 - A second WC branded tent topper (\$200)
 Plastic A-Frame Signs
 - Upgrade Signage budget up to \$1250
 - Additional Port-a-Potty +\$400
 - Longer security- double
- There was no money spent on sidewalks programs, but there were two applications. We are checking on their status.
- Add line item for public art.
- Holiday Party- keep it at \$3000
- New Neighbor Welcome Party- up to \$2000
- Cookie Exchange: up to \$200
- Increase Egg Hunt to \$175
- Add postcards \$1000
